Your privacy is important to us, and we take it seriously. We provide this Privacy Policy to explain how Hoffman & Hoffman, Inc. ("we," "us," or "our") collects, uses, and discloses your information.

#### What This Policy Covers

### **Information We Collect**

#### Information You Provide To Us

We collect information you provide directly to us, such as when you fill out a form, send us an email, or request information. The types of information we collect may include your name and your contact information (email address and phone number).

#### **Information We Collect Automatically**

You can browse our Websites without telling us who you are or revealing your personally identifying information. But like most websites, we collect usage information automatically from all visitors to our Websites. Usage information may include your IP address or other unique device identifier; your web browser and operating system; the date and time of your visit; the pages from which you navigate

#### **Information Collected by Third Parties**

#### **Google Analytics**

Because we have integrated Google Analytics, certain information is shared with Google, such as the URL of the page you are visiting and your IP address. ### How We Use Your Information
